Admission to the College for the training of persons in educational programs provided by statements of persons who have no education or below basic general secondary education.

Application deadline for training in basic professional educational programs of vocational education:

Acceptance of documents for the first course begins June 20.

Acceptance of applications in college on a full-time operating until August 15, and in the presence availability in college admission documents is extended to 01 October this year.

When applying (in Russian) for admission to college entrant presents the following documents: Citizens of the Russian Federation:

- The original or a copy of documents proving his identity, nationality;
- The original or a copy of the document on education and (or) qualification ;
- 4 photos .

Foreign citizens and stateless persons , including compatriots residing abroad must submit the following documents:

- A copy of an identity document supplied , or a document certifying of a foreign citizen in the Russian Federation , in accordance with Article 10 Federal Law of July 25, 2002 № 115-FZ "On the Legal Status of Foreign Citizens Russian Federation ";

- The original foreign document on education and (or) on the qualifications (or his duly certified copy) if witnessed by the specified document education is recognized in the Russian Federation at the appropriate education accordance with Art. 107 of the Federal Law of 29 December 2012 № 273 -FZ "On Education in Russian Federation "(in the case of the Federal Law - also certificate Recognition of foreign education) ;

- A duly certified translation into Russian foreign document state education and (or) the qualifications and annexes (if the latter provided by the laws of the State in which such document) ;

- Copies of documents or other evidence to support the membership compatriots living abroad, the groups provided article . 17 of the Federal Act of May 24, 1999 № 99 -FZ " On State Policy of the Russian Federation concerning compatriots abroad ";

- As well as the documents listed for Russian citizens .
